SUPERSEDED - ENHANCED PRE-EMPLOYMENT MEDICAL SCHEME PHILIPPINES - UPDATE FOR 2008

On the 7th December 2006 we released a circular advising of the expansion of our Enhanced Pre-employment Medical Scheme in the Philippines to include three new clinics. We are pleased to announce that following inspections by our independent doctor from Medical Rescue International, and the undersigned, we will be recommending the same five clinics for 2008.

It is the Association's aim to constantly review this programme to ensure that testing levels are appropriate. We propose to retain the current set medicals, but are advising Members to consider abdominal ultrasound tests following advice from our clinics that the incidents of renal and gall stones are increasing.

We do not propose to include these tests in our packages, but the clinics have agreed to make same available, the costs for which are to be negotiated locally.
