Crew who originate from UK, Brazil, South Africa, Europe & Middle East are retained at Airport for 6 to 8 hours until receiving the test report and upon receipt of Negative Report, they have been permitted to leave the Airport. With regard to crew from other Origin (exclude above Countries) are permitted to leave the Airport to the designated hotel no sooner Covid19 test is done/fee received either from crew or from the agents. We also understand that the agents are not getting the test reports timely for these crew, hence, inorder to save time, upon crew reaching the designated hotel, once again, crew under COVID19 test in authorised Lab as arranged by the Agents, and basis Negative Report, they are joining the vessel within 72 hours upon their landing. Crew should wear full PPE while joining the vessel.
